POLL RESULTS OF THE ANNUAL GENERAL MEETING HELD ON 30 JUNE 2026

At the annual general meeting (the “AGM”) of China Parenting Network Holdings Limited (the “Company”) held on Tuesday, 30 June 2026, all the proposed resolutions as set out in the notice of the AGM dated 5 June 2026 were taken by way of poll.

As at the date of the AGM, the total number of issued shares of the Company was 47,837,422 shares, which was the total number of shares entitling the holders to attend and vote for or against the proposed resolutions at the AGM. There were no restrictions on any shareholders casting votes on any of the proposed resolutions at the AGM. There were no shares entitling the holder to attend and abstain from voting in favour of the proposed resolutions at the AGM as set out in Rule 13.40 of the Rules Governing the Listing of Securities on the Stock Exchange of Hong Kong Limited (the “Listing Rules”). No shareholder was required under the Listing Rules to abstain from voting on the proposed resolutions at the AGM. None of the shareholders has stated his/her/its intention in the circular of the Company dated 5 June 2026 to vote against or to abstain from voting on any of the proposed resolutions at the AGM.

The Company’s share registrar in Hong Kong, Tricor Investor Services Limited, was appointed as the scrutineer at the AGM for the purpose of vote-taking. All the resolutions were approved by the shareholders of the Company. The poll results in respect of the respective resolutions proposed at the AGM were as follow:
