### **SUBSCRIPTION OF NEW SHARES UNDER GENERAL MANDATE**

On 17 June 2026 (after trading hours), the Company and each of the Subscribers entered into the Subscription Agreements, pursuant to which the Company has conditionally agreed to allot and issue, and the Subscribers has conditionally agreed to subscribe for, an aggregate 3,300,781 Subscription Shares at a subscription price of HK\$0.325 per Subscription Share.

The 3,300,781 Subscription Shares represent approximately 6.90% of the total number of Shares in issue as at the date of this announcement and approximately 6.45% of the total number of Shares in issue and as enlarged by the allotment and issue of the Subscription Shares, assuming that there will be no changes in the issued share capital of the Company between the date of this announcement and the date of allotment and issue of the Subscription Shares.

The subscription price of HK\$0.325 per Subscription Share represents: (i) a discount of approximately 19.75% over the closing price of HK\$0.405 per Share as quoted on the Stock Exchange on the date of the Subscription Agreements; and (ii) a discount of approximately 19.55% over the average closing price of HK\$0.404 per Share as quoted on the Stock Exchange for the last five consecutive trading days up to and including the Last Trading Day.

Completion of the Subscription Agreements is conditional upon, among others, the Listing Committee of the Stock Exchange having granted approval for the listing of, and permission to deal in, the Subscription Shares.

The gross proceeds and net proceeds from the Subscription will be approximately HK\$1.1 million, which is intended to be used for repayment of part of the Group's outstanding professional fees and expenses.

The Subscription Shares will be issued under the General Mandate and is not subject to the Shareholders' approval.

To the best of the Directors' knowledge, information and belief, having made all reasonable enquiries, each of the Subscribers is a third party independent and not connected with the Company and any of its connected persons.

## **Number of Subscription Shares**

Pursuant to the Subscription Agreements, Ms. Chan, Mr. Woo and Ms. Nangoi shall subscribe for 382,699 Subscription Shares, 717,561 Subscription Shares and 2,200,521 Subscription Shares, respectively.

The 3,300,781 Subscription Shares represent approximately 6.90% of the total number of Shares in issue as at the date of this announcement and approximately 6.45% of the total number of Shares in issue and as enlarged by the allotment and issue of the Subscription Shares, assuming that there will be no changes in the issued share capital of the Company between the date of this announcement and the date of allotment and issue of the Subscription Shares. The aggregate nominal value of the Subscription Shares is HK\$165,039.05.

The Subscription Shares will rank pari passu in all respects among themselves and with all other fully paid Shares in issue on the date of issue of the Subscription Shares.

## **Subscription price of the Subscription Shares**

The subscription price of HK\$0.325 per Subscription Share represents:

- (i) a discount of approximately 19.75% over the closing price of HK\$0.405 per Share as quoted on the Stock Exchange on the date of the Subscription Agreements; and
- (ii) a discount of approximately 19.55% over the average closing price of HK\$0.404 per Share as quoted on the Stock Exchange for the last five consecutive trading days up to and including the Last Trading Day.

The subscription price of the Subscription Shares was arrived at after arm's length negotiations between the Company and the Subscribers with reference to the last trading price of the Shares on the Last Trading Day. The Directors are of the view that the subscription price of the Subscription Shares is fair and reasonable and in the interest of the Company and the Shareholders as a whole. The subscription price of 3,300,781 Subscription Shares is approximately HK\$1,072,754, which shall be satisfied by each of the Subscribers by payment to the Company in cash upon completion of the Subscription.

## **Condition precedent**

Completion of the Subscription Agreements is conditional upon the satisfaction of the following conditions:

- (i) the Listing Committee of the Stock Exchange having granted the approval for the listing of, and the permission to deal in, the Subscription Shares to be issued and such approval and permission having not been subsequently withdrawn or revoked;
- (ii) all necessary approvals or resolutions of the Directors having been obtained or passed in respect of the signing of the Subscription Agreements and the completion of the Subscription and issuance of the Subscription Shares;
- (iii) all the Company's warranties as set out in the Subscription Agreements being true, complete and accurate in all respects and not misleading in any respect;

- (iv) the passing of resolutions of the Directors to approve the Subscription Agreements and the transactions contemplated herein including but not limited to the entering into of the Subscription and the issuance of the Subscription Shares; and
- (v) the Subscribers' warranties as set out in the Subscription Agreements being true, complete and accurate in all respects and not misleading in any respect.

Completion of the Subscription Agreements shall take place within five working days after the date on which the condition precedent to the Subscription Agreements is fulfilled. If any of the above conditions have not been fulfilled or satisfied or complied with or waived on or before the Long Stop Date (or such other date as the parties may agree), the Subscribers shall not be obliged to complete the Subscription. For the avoidance of doubt, Completion of each of the Subscription Agreements is not inter-conditional upon each other.

### **GENERAL MANDATE**

The Subscription Shares will be issued under the General Mandate approved on 30 June 2025 and is not subject to the Shareholders' approval. The maximum number of Shares that can be issued under the General Mandate is 8,641,558 Shares, being 20% of the total number of Shares in issue as at the date of the annual general meeting of the Company held on 30 June 2025.

As at the date of this announcement, the Company has allotted and issued 4,629,630 Shares under the General Mandate. For details, please refer to the announcements of the Company dated 29 December 2025, 30 December 2025 and 19 January 2026.

### **LISTING APPLICATION**

An application will be made by the Company to the Listing Committee of the Stock Exchange for the listing of, and permission to deal in, the Subscription Shares.

### **REASONS FOR THE SUBSCRIPTION AND THE USE OF PROCEEDS**

The Company is an investment holding company and the Group is an online platform focusing on the CBM (children, babies, and maternity) market in China and provides users with content, community, new media, e-commerce, smart hardware and other related services through a portfolio of websites and mobile applications.

The Group intends to raise additional funding through the issuance of the Subscription Shares to improve the Group's financial position and for the repayment of part of the Group's outstanding professional fees and expenses. The Directors consider that the Subscription represents an opportunity for the Group to reduce its liabilities and broaden the capital base and Shareholder base of the Company. Accordingly, the Directors consider that the Subscription is in the interest of the Company and the Shareholders as a whole.

The gross proceeds and net proceeds from the Subscription will be approximately HK\$1.1 million, which is intended to be used for repayment of part of the Group's outstanding professional fees and expense of the Group. The net subscription price per Subscription Share will be approximately HK\$0.325. Based on the closing price of HK\$0.405 per Share on the date of the Subscription Agreements, the Subscription Shares have a market value of approximately HK\$1,336,816.

The Directors consider the terms of the Subscription Agreements, which were negotiated on an arm's length basis and agreed on normal commercial terms between the parties thereto, are fair and reasonable, and the Subscription is in the interests of the Company and Shareholders as a whole.
